One member's voice **Our Fears Fall From Us** A story of experience, strength, and hope

to another human being the exact nature of our wrongs.

I came into Alcoholics Anonymous willing to do whatever it took to stav sober. I was raised in the Catholic Church, so going into a confessional and telling a priest everything I had done since my last confession was not unusual. But, I had long since stopped going to church or telling a priest anything.

During my drinking, I was taken to a crisis unit where I ended up talking to a shrink for a couple of months. Then one day he pronounced that I was well enough to go out and meet the world. The bottom line was I had never told him anything about me or my drinking problem. I only told him what I

Step Five: Admitted to God, to ourselves, and wanted him to know and think about me. After taking the first four steps of the

Alcoholics Anonymous program—and by now understanding honesty was the guiding principle for me as an alcoholic—I knew that I was actually going to have to sit down with my Fourth Step and share it with another human being. Step Five is definitely an action step and taking it means we have shared the exact nature of our character defects with another human being.

The Big Book of Alcoholics Anonymous, clearly points out, "If we skip this vital step, we may not overcome drinking." As I said I was willing to do anything, because by the time I got to the Fifth Step I was starting to experience a new way of life and was not Continued on page 2 ->

Tradition Five Our primary purpose, the ultimate spirituality

"Each group has but one primary purpose — to carry its message to the alcoholic who still suffers."

We live in interesting times. Our fellowship mirrors society at large and all of its problems, which are only magnified because of the nature of our personalities. Tradition Five is a dramatic reminder of why we have AA groups and why we are here.

When Bill Wilson wrote the traditions based on experiences that the fledgling fellowship endured, he envisioned that we could be sidetracked easily from our single, primary purpose. That is why Tradition Five is so important. The new person in the last stages of active alcoholism who shows up at our meeting room door needs not only to see the seriousness of our disease, but also that we take it very seriously.

When a group comes together. Tradition Five reminds us of this. Yes, it's nice to go to meetings and see our friends each day for an hour. It is nice to laugh and joke. It's nice to feel good. But it's imperative, if we are to survive as a fellowship, to understand our purpose-why we are here.

AA literature tells us that our primary purpose is to stay sober and to help another alcoholic. This is the individual's calling if he or she wants to have a happy useful life. As a group, we are called on collectively to remember that our primary

purpose is to carry the message to the alcoholic who still suffers.

In the early years of sobriety it is all about self. In working the 12 steps in our own lives and over time, Tradition Five takes paramount importance, and the program becomes one of "we" instead of "I."

We love our picnics, our dances, and our dinners. We love to dine together and to enjoy fellowship. All of this is important to our well-being, but let's not forget the newcomer. More importunately, lets not forget the stillsuffering alcoholic who may or may not be drinking. Continued on page 6 ->

about to give it up for anything. I was not in favor of taking this step with my sponsor. I loved her but felt she was too old for me to tell her some of my inventory.

I was blessed at the time with a gal named Pat from California who was a member of my group. I felt that Pat was open-minded, and I needed that assurance. I prayed before disclosing myself to Pat.

She was just the right person for me. She was younger than my sponsor, but when I shared the secret that I would have "gone to the grave with," she shared a similar life experience of hers with me. I felt awed and relieved. From that point forth I had no problem telling her the whole story.

I felt such relief after taking this step. I no longer had to walk in shame and embarrassment. To be entirely honest with another human being frees us from the power of our past to hurt us. Bill W. wrote, "We can look the world in the eye. We can be alone at perfect peace and ease. Our fears fall from us." These I believe are the Step Five promises.

To be relieved from fear was wonderful. Of course I felt closer to my higher power and to the people in Alcoholics Anonymous. I felt as though we had taken this trip together— the people that had gone before me and the people that I knew would continue to come after me.

There is another part of the fifth step that is so very satisfying and rewarding that I hope none of you will miss it. For anyone who has enjoyed a life of sobriety and has had an opportunity to sponsor others in the program and hear their fifth steps you know just how special this experience is.

I sponsor women today who hear fifth steps and are amazed at how gratified they feel to be of service to others and to experience being happily, usefully whole. When you are allowed to hear a fifth step, you truly experience God's grace in your fellow man's life.

The Big Book says. "Carefully reading the first five proposals we ask, if we have omitted anything for we are building an arch through which we shall walk a free man at last. Is our work solid so far? Are the stones properly in place? Have we skimped on the cement put into the foundation? Have we tried to make mortar without sand?"

STEP FIVE

"Admitted to God, to ourselves, and to another human being the exact nature of our wrongs."

If we skip this vital step, we may not overcome drinking. Time after time newcomers have tried to keep to themselves certain facts about their lives. Trying to avoid this humbling experience, they have turned to easier methods. Almost invariable they got drunk.

Having persevered with the rest of the program, they wondered why the fell. We think the reason is that they never completed their housecleaning.

They took inventory all right, but hung on to some of the worst items in stock. They only thought they had lost their egoism and fear; they only thought they had humbled themselves. But they had not learned enough of humility, fearlessness, and honesty, in the sense we find necessary, until they told some else *all* their life story.

Somehow, being alone with God doesn't seem as embarrassing as facing up to another person. Until we actually sit down and talk about what we have so long hidden, our willingness to clean house is still largely theoretical. When we are honest with another person, it confirms that we have been honest with ourselves and with God.

2. Am I willing to explain firmly to a newcomer the *limitations* of AA help, even if he gets mad at me for not giving him a loan?

3. Have I today imposed on any AA member for a special favor or consideration simply because I am a fellow alcoholic?

4. Am I willing to twelfth-step the next newcomer without regard to who or what is in it for me?

5. Do I help my group in every way I can to fulfill our primary purpose?6. Do I remember that AA old-timers, too, can be alcoholics who still suffer? Do I try both to help them and to learn from them?

CONCEPT FIVE

Throughout our world services structure, a traditional "Right of Appeal" ought to prevail, thus assuring us that the minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered.

The "Right of Appeal" recognizes that minorities frequently can be right; that even when they are in error they still perform a valuable service when they compel a thoroughgoing debate on important issues. The well-heard minority, therefore is our chief protection against an uninformed, misinformed, hasty or angry majority.

District 17 Corner Alcoholics and Anonymity online. Guidelines. Traditions. Common Sense.

AA Guidelines are compiled from the shared experience of AA members in various service areas. They also reflect guidance given through the twelve traditions and the General Service Conference (U.S. and Canada).

In keeping with our tradition of autonomy, except in matters affecting other groups or AA as a whole, most decisions are made by the group conscience of the members involved. The purpose of these Guidelines is to assist in reaching an *informed* group conscience.

Based on AA's strength and history of personal and intimate sharing, the spiritual nature of "one drunk talking to another" is an ongoing concern when discussing technology as a source of AA information. Even many Internet-savvy AA members say that they do not want the ease of new technology to detract from the one-on-one sharing that has been so essential to our Fellowship and our recovery from alcoholism.

It is helpful to remember that there is no need to let the speed of technology dictate the speed of our actions. Based on shared experience to date, website committees not only discuss the technical aspects of developing a website but also address questions related to preserving the spiritual connection created by one alcoholic talking with another.

Some committees have reported a loss of the "personal touch" when relying too heavily on technology, while others report that they have found a balance that works for them. It will be up to a committee's informed group conscience to determine what AA content is useful and appropriate. The good news is that today's decisions can be reviewed, revised, abandoned or expanded. A committee can always try something for a certain length of time and then come back and determine how well it is working. This is the AA way!

AA Traditions

We observe all AA's principles and Traditions on AA websites. **Anonymity**—As anonymity is the "spiritual foundation of all our Traditions," we practice anonymity on public AA websites at all times. Unless passwordprotected, an AA website is a public medium, and, therefore, requires the same safeguards that we use at the level of press, radio and film. In simplest form, this means that AAs do not identify themselves as AA members using their full names and/or full face photos. For more information on anonymity online, see the section of this Guideline, "Guarding Anonymity Online."

Guarding Anonymity Online

Modern communication in AA is flowing from one alcoholic to another in ways that are high-tech, relatively openended and evolving quickly. Protecting anonymity is a major concern for members, who are accessing the Internet in ever-growing numbers.

A guiding resource of shared AA experience regarding websites is the GSO service piece "Frequently Asked Questions about AA websites," question seven.

General Social Networking websites

MySpace, Facebook, and other social networking websites are public in nature. Though users create accounts and utilize usernames and passwords, once on the site, it is a public medium where AA members and non-AAs mingle. As long as individuals do not identify themselves as AA members, there is no conflict of interest. However, someone using their full name and/or a likeness, such as a full-face photograph, would be contrary to the spirit of the Tradition Eleven, which states in the long form that, "... our [last] names and pictures as AA members ought not be broadcast, filmed or publicly printed."

Experience suggests that it is in keeping with the Eleventh Tradition not to disclose AA membership on social networking sites as well as on any other website, blog, electronic bulletin board, etc., that is not composed solely of AA members, is not password protected or is accessible to the public.
