A story of experience, strength, and hope

Step Eight: Made a list of all persons we had passed, when during a meeting I realized harmed, and became willing to make amends to them all.

It was imperative for me to remember that once I had hit my bottom and actually joined the Alcoholics Anonymous program that I had made a decision: I was willing to go to any length for victory over my alcoholism. Step Eight was a vital party of my sobriety

My first bout with the steps of Alcoholics Anonymous was in a non-AA related facility where, after reading my "exact-nature-of-my -wrongs" list to the local clergy, I was encouraged to have a ritualistic, celebratory burning of what I had written.

After I was released from the facility, I began attending AA meetings believing that I had completed my program as far as the steps were concerned. Some time had

what had been my true bottom. It was that point at which ONE drink of alcohol had become more important to me than the love of my children.

After that realization I made a decision and commitment to myself that no matter what others thought or said, I was not going to drink again. I would go to meetings and tell the story of my bottom and help others to hit their bottoms too. I would be just fine doing it my way on my own, thank you.

Then after a few short months, I was blindsided by the overwhelming desire to drink. It was all I could think of. I was shocked, surprised, and quite emotionally debilitated. After all that progress on my own, how had I gotten back to that point? I was baffled and stunned. My so-called power

Tradition Eight Freely you have received, freely give.

"Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers. "

The very basis of Tradition Eight is that our Twelfth Step work is given freely and that sharing our experience strength and hope is necessary for us to stay sober. The group conscience is made up of members of a group and all group activities are guided by our group conscience.

The group conscience elects individuals to serve as secretary, treasurer, General Service Representative, Intergroup 17 Representative, Grapevine representative, and facilitator. None of these individuals are paid to fill these positions.

In addition, our district — District 17 of the North Florida Area of AA — also has individuals serving in various volunteer positions. Again, these services are provided by individuals for no remuneration.

We do not hire counselors. physicians, psychologists, or other similar professionals to serve the group members nor to do Twelfth-Step work for Alcoholics Anonymous.

What about the "AA" clubs? These are private organizations that may make their facilities available for AA groups to hold AA meetings, often for a specified

rental fee. The private facility itself may hire service personnel to cook, clean, and do other administrative and maintenance functions, but these individuals are not employees of an AA group.

Our General Service Office requires administrative and clerical personnel to provide a wide range of much needed services to AA groups, the general AA membership, and cities and areas that want to start an AA group, central office, or intergroup. These employees provide support that helps us in our Twelfth-Step work.

of choice had truly been lost.

Because of certain external circumstances beyond my control, I fortunately did not drink. But having fully recognized my lack of power, I became willing to join AA, to serve AA, and to work the remaining suggested steps of the AA program of recovery.

However, I ran into a problem when it came to Step Eight. The Big Book indicates that we should have a list of all person we have harmed, the one we made when we took inventory in Step Four. But oh no! Yet another kick to my already battle-scarred ego. I had already burnt my written inventory

"ritualistically" as I'd been told.

So I succumbed to the idea that perhaps a sponsor could be of help, and I got one. He suggested that if I really wanted to continue on with the recovery solution. I might want to complete another written inventory He also suggested that this time I might want to use the outline from the *Big Book*.

With some resistance I complied and after writing my inventory, I followed through with my Steps Five, Six, and Seven of my journey. This time, I was able to complete my eighth step using the list from my fourth step inventory.

It was easy listing the names of those I had harmed as far as pen and paper were concerned. The bigger pill to swallow was the knowledge I gained from an honest, in-depth look at the human impact my character flaws had on those I had harmed, the ones who cared for and loved me.

As I looked back at my list, I could see how I was trapped in fear and full of self -pity, resentments, selfishness, and selfcenteredness. My delusional ambitions and demands on others were heart wrenching to my innermost self. I always thought I was much better than I really was.

My sponsor suggested that I remove some of those on my list because they were double dumb. He said that I might be wanting to punish them, get revenge, or just scold. That I might be just slightly forgetting for a moment that this eighth step list was of people I had harmed, not the other way around.

To just sum up this step, after looking at Step Eight at this point of my spiritual journey, it's obvious that for me to have gained a daily reprieve from choosing alcohol over the love of humanity, my family, friends, and those yet to come to the program that I needed to be willing, honest, and open minded about the full impact of my past destructive behavior and attitudes.

I needed a solution to my drinking problem. I needed to invest in my recovery. I needed to bring about a more positive change in my life. I needed to find serenity not only with myself, but with others. And I needed to seek out a power greater than myself.

I must say, for the most part, that has come to pass. My old AA mentor once said, "These steps are not meant to be easy, not meant to be hard, no not at all, they are meant to be effective."

I also want to say that I'm grateful not to have missed out on Step Eight as a result of some ritual. From my heart to yours, may the Great Spirit of AA be your shining light.

Some people choose to run farms, halfway houses, and detox centers for recovering alcoholics. These are privately run facilities and not affiliated with Alcoholics Anonymous World Services or any AA group.

"Made a list of all persons we had harmed and became willing to make amends to them all."

Now we need more action, without which we find that "Faith without works is dead." Let's look at Steps Eight and Nine. We have a list of all persons we have harmed and to whom we are willing to make amends. We made it when we took inventory. We subjected ourselves to a drastic self-appraisal.

Now we go out to our fellows and repair the damage done in the past. We attempt to sweep away the debris which has accumulated out of our effort to live on self-will and run the show ourselves. If we haven't the will to do this, we ask until it comes. Remember it was agreed at the beginning we would go to any lengths for victory over alcohol.

Probably there are still some misgivings. As we look over the list of business acquaintances and friends we have hurt, we may feel diffident about going to some of them on a spiritual basis. Let us be reassured. To some people we need not, and probably should not emphasize the spiritual feature on our first approach.

We might prejudice them. At the moment we are trying to put our lives in order. But this is not an end in itself. Our real purpose is to fit ourselves to be of maximum service to God and the people about us. It is seldom wise to approach an individual, who still smarts from our injustice to him, and announce that we have gone religious.

Alcoholics Anonymous should remain forever nonprofessional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going perform those services for which we might otherwise have to engage nonalcoholic. Such special services may be well recompensed. But our usual AA Twelfth-Step work is never to be paid

Tradition 8 Checklist

- 1. Is my own behavior accurately described by the Traditions? If not, what needs changing?
- 2. When I chafe about particular Tradition, do I realize how it effects others? 3. Do I sometimes try to get some reward—even if not money—for my personal AA efforts?
- 4. Do I try to sound in AA like an expert on alcoholism? On recovery? On medicine? On sociology? On AA itself? On psychology? On spiritual matters? Or, heaven help me, even on humility?
- 5. Do I make an effort to understand what AA employees do? What workers in other alcoholism agencies do? Can I distinguish clearly among them?
- 6. In my own AA life, have I any experiences which illustrate the wisdom of this Tradition?
- 7. Have I paid enough attention to the book Twelve Steps and Twelve Traditions? To the pamphlet AA Tradition. How it Developed.'?

The trustees [of the General Service Board are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.

- Do we understand the relationship between the two corporate service entities (A.A. World Services, Inc., the A.A. Grapevine) and the General Service Board?
- How can the business term "custodial oversight" apply to the trustees' relationship to the two corporate service entities?
- Does my home group subscribe to GSO 's bimonthly newsletter Box 4-5-9? The AA Grapevine? Do I?

We finally learned what the business world well knows: that we could not, at the level of top management, run a large, active and full-fledged business entity with loose-jointed committees and departments.

However, experience dating from our earliest days strongly suggest that future Trustees and service workers, in the supposed interests of accounting simplicity, tax savings, and hoped-for efficiency, will be periodically tempted to go in for concentration and consolidations of one kind or another. Should this be again attempted, we know that the risk of making an administrative shambles out of the total operation will be great indeed.

These observations are not intended to bar any future needful change. It is urged only that we avoid unnecessary repetitions of those painful experiences and mistakes of the past which sometimes resulted from too much concentration of money and authority.

How clear is your group conscience? How about a searching and fearless inventory — of your group?

Many groups periodically hold a "group inventory meeting" to evaluate how well they are fulfilling their primary purpose: to help alcoholics recover through AA's suggested Twelve Steps of recovery. Some groups take inventory by examining our Twelve Traditions, one at a time, to determine how well they are living up to these principles.

The questionnaire below, compiled from A.A. shared experience, may be useful in arriving at an informed group conscience. Groups will probably wish to add questions of their own.

AA Group Inventory

- 1. What is the basic purpose of the group?
- 2. What more can the group do to carry the message?
- 3. Is the group attracting alcoholics from different backgrounds? Are we seeing a good cross-section of our community?
- 4. Do new members stick with us, or does the turnover seem excessive? If so, why? What can we as a group do?
- 5. Do we emphasize the importance of sponsorship? How effectively? How can we do better?
- 6. Are we careful to preserve the anonymity of our group members and other A.A.s outside the meeting rooms? Do we also leave the confidences they share at meetings behind?
- 7. Do we take the time to explain to all members the value to the group of keeping up with the kitchen/housekeeping chores and other essential services that are part-and-parcel of our Twelfth-Step efforts?
- 8. Are all members given the opportunity to speak at meetings and to participate in other group activities?
- 9. Mindful that holding office is a great responsibility not to be viewed as the outcome of a popularity contest, are we choosing our officers with care?
- 10. Are we doing all we can to provide an attractive meeting place?
- 11. Does the group do its fair share toward participating in the purpose of AA as it relates to our Three Legacies of Recovery, Unity and Service?
- 12. What has the group done lately to bring the A.A. message to the attention of professionals in the community—the physicians, clergy, court officials, educators and others who are often the first to see alcoholics in need of help?
- 13. How is the group fulfilling its responsibility to the Seventh Tradition?
