## A second chance at life A story of experience, strength, and hope

Step Eight. Made a list of all persons we had though I knew where to find the instrucharmed and became willing to make amends to them all.

After my last relapse, my spirit was broken and lost. I had no power to run my life anymore. After several years in and around recovery with very little success, I desperately needed help. My best efforts at "playing AA" got me drunk, suicidal, and broken.

At six days sober and still in detox from the booze and dope, I sat in my sponsor's car and cried like a baby. He explained to me that all my years around AA had not been wasted. He reminded me that I already knew how to take personal inventory because he had taught me where the instructions are: inside the Big Book.

He also told me point-blank that even

tions, I had never actually followed them! And THAT was why I had been getting

He told me that I should pick up a white chip that evening and meet him an hour before the noon meeting the next day with my inventory in hand! He told me that I had been "taking my time" with the steps for the past three years, and now it was finally time to actually work them!

The next day I had a list of resentments, fears, and harms to others. My sponsor went through my inventory with me, identifying my defects and showing me where those defects and my actions had been harming others. He told me to go home afterward and spend the next hour or so reviewing my inventory and the first five steps.

## **Tradition Eight**

## Twelfth step work? Understanding the difference.

"Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers."

Tradition Eight has continued to evolve as more has been revealed about the complexities of alcoholism. In 1940, what we knew about alcoholism was that we could not safely drink, and we had to change our thinking.

In 1948, Bill W wrote about the necessity of hiring workers to do clerical and other types of work for AA offices. He said we should hire people and pay them a fair wage.

In the late 1970s, with the advent of treatment centers, great strides in the therapeutic treatment of

alcoholism, and corporate employee assistance programs that would pay for all or part of treatment brought also came an influx of therapists, marketers, and other administrators. Many of them held very highly paid positions.

For some, this seemed to create a conflict with Tradition Eight. The AA purists criticized and looked down their noses at those who made a living in these fields. There was real dissension among us.

Thankfully we have evolved our understanding that a therapist who is also a member of AA can and should be able to practice in the field of therapeutic treatment and also belong to the fellowship.

Many purists look at the long form of this tradition that states, "We define professionalism as the occupation of counseling alcoholics for fees or hire," and take that to mean that no alcoholic can work anywhere that charges people for counseling.

Many recovering alcoholics decide to change careers and become therapists and/or counselors in order to

He told me to make a clear list of my defects of character and another list of the people upon whom I had inflicted those defects. (This was to become my eighth step list.) He told me to turn to page 76 in my *Big Book* when I was done, and if I was ready to let God finally be in charge of my life, I was to say the seventh step prayer.

At six days sober, I had taken Step One. Recognizing I was doomed. I took Step Two when I crawled into my sponsor's car and told him about my relapse, knowing AA was my last hope. I surrendered to Step Three when I followed his directions and picked up a white chip and began writing my fourth step.

The next day I took Step Five with my sponsor. He guided me through Steps Six and Seven, and the he showed me where I was to find the list of names which belonged on my eighth step by reminding me that page 76 in the *Big Book* says, "We have a list of all persons we have harmed and to whom we are willing to make amends. We made it when we took inventory." On day eight I began to make amends.

For the past 14 years, I have been crossing off names from that original list one person at a time. I have not had a drink since I made that list and became willing to make those amends, continue to take personal inventory, seek God, and help others.

I am forever grateful for that sponsor who guided me through my inventory to show me where that list was to be found and am forever grateful for AA for giving me a second chance at life.

help others who are afflicted. Who better to understand the sufferer as long as we do not cross the line and solicit and/or charge for Step Twelve work?

Let's remember there is a difference between doing Twelfth Step work for pay and earning a degree in counseling or working in a hospital or treatment center — where more and more newcomers begin their path towards sobriety. Most of the counselors I know do not substitute their jobs for the AA program. They also go to AA meetings and carry the message "for free and for fun."

## **District 17 Corner**

District 17 seeks service minded individuals to fill two key service positions coming open this September: District Committee Member (DCM) and Alternate DCM.

Responsibilities: The DCM serves as an essential link between the district's group GSRs and the area delegate to the General Service Conference. The DCM serves as leader of the district committee, made up of all GSRs, and is a member of the area committee, representing the district's group conscience at the area level.

Qualifications: A DCM should have enough sobriety (generally four or five years) to be eligible for election as delegate and needs to have time and energy to serve the district well. The DCM usually has served as a GSR and is elected by other GSRs. If the person chosen is a current GSR, a new GSR should be elected to fill the position.

The Alternate DCM assists and serves as a backup for the DCM.

from the A.A. Grapevine

These questions were originally published in the AA Grapevine in conjunction with a series on the Twelve Traditions that began in November 1969 and ran through September 1971. While they were originally intended primarily for individual use, many AA groups have since used them as a basis for wider discussion.

#### **Tradition Eight**

Alcoholics Anonymous should remain forever nonprofessional, but our service centers may employ special workers.

- I. Is my own behavior accurately described by the Traditions? If not, what needs changing?
- 2. When I chafe about any particular Tradition, do I realize how it affects others?
- 3. Do I sometimes try to get some reward—even if not money—for my personal AA efforts?
- 4. Do I try to sound in AA like an expert on alcoholism? On recovery? On medicine? On sociology? On AA itself? On psychology? On spiritual matters? Or, heaven help me, even on humility?
- 5. Do I make an effort to understand what AA employees do? What workers in other alcoholism agencies do? Can I distinguish clearly among them?
- 6. In my own AA life, have I any experiences which illustrate the wisdom of this Tradition?
- 7. Have I paid enough attention to the book *Twelve Steps and Twelve Traditions?* To the pamphlet AA Tradition—How It Developed?
