#### The Nature of Service

An awesome prescience permeates the Ninth Tradition of Alcoholics Anonymous. Our early members distilled their experience to form the wisdom embodied in our 12 Traditions, the "why" it works of our Fellowship.

In a business meeting a dozen or so years ago, it was announced several vacant service positions would be appointed the next time we met. A number of members expressed eager interest, at which point an old-timer remarked with a chuckle that anyone who wanted a position should not be nominated. He was well aware of our propensity for self-promotion and power wielding.

I did not attend that next meeting. The day after it occurred I was filling my regular Monday morning slot at Intergroup when said old-timer walked in and informed me I was the new secretary of our group. My protests - I was not there, I did not volunteer - were met with his response that that was why I was the new secretary.

A rampant characteristic in alcoholics, a reluctance to obey authority, is addressed by the nature of the disease itself – our obedience comes from within. "Great suffering and great love are A.A.'s disciplinarians; we need no others." Our natural desires have to be sacrificed. The spirit of service negates nourishing our selfishness. Instead, we are here to help, to serve in a

custodial capacity as part of a service board or committee.

There are no bosses or gurus in our Fellowship. "Not GSO, not the humblest group conference can issue a single directive to any A.A. member." We can't be dictated to individually or collectively. We can, however, entertain the advice and suggestions from more experienced members. The individual's defects are mirrored in others, but so are our assets. This reminds us that there is a Higher Power and we are not it. We become willing to try it another way. The willingness reasons are supplied by our Higher Power.

This Tradition states we ought never be organized yet we must be ready to be useful to others. We agree to be responsible for tasks, not to take on authority. The purely practical needs of our Fellowship are given life by the spirit of service. There is one vote apiece. There is no ambiguity in the phrase "directly responsible to those they serve".

Our individual goals of spiritual simplicity, to be true to a vision and a purpose, translate into the aim of our service, to bring sobriety to all who want it. We come out of isolation into harmony. So go we, go our service boards, our committees, our Fellowship, and A.A. as a whole.

#### My journey of making amends

Step Nine. Made direct amends to such persons wherever possible, except when to do so would injure them or others.

I read Step Nine for the very *first* time long before I ever participated in it. On first reading, I thought to myself, "Hmmm. Say, 'I'm sorry.' I can do that."

Fortunately, for my recovery, that was not all I had to do. What I found eventually was an ability to tell the truth, to apologize for my behavior, and — the most important part, of course — to *change* my behavior!

By the time I got around to taking Step Nine I had experienced some wonderful gifts from the program and from working Steps One through Eight. I didn't want to stop receiving those gifts, which meant I had more work to do.

I learned that Step Nine is basically the last part of my "housecleaning." My life had been spared by my Higher Power. I was willing to go to any lengths! The obsession was gone! For the first time ever, I wanted to be sober more than I wanted to drink!

That had never happened before. I finally felt like I was able to breathe! The *Big Book*, Alcoholics Anonymous, says on page 79, "Although these reparations take innumerable forms, there are some general principles which we find guiding. Reminding ourselves that we have decided to go to any lengths to find a spiritual experience, we ask that we be given strength and direction to do the right thing, no matter what the personal consequences may be...."

I already had the list for my ninth step amends. I made it when I did my fourth and fifth steps. Those were obvious ones I had to do.

Then there were ones that I couldn't do face to face because of a death or other extenuating circumstances. For me, these were not simple apologies; they had to be a living amends.

My sponsor told me that I had to go and acknowledge my behavior, and then change my behavior. The spiritual principle behind Step Nine is "forgiveness." It wasn't just about forgiveness from others; it was a forgiveness of me that I sought.

I did some horrible things throughout my drinking years and carried around a ton of guilt and shame, as most of us do. I wanted to feel "right" with my God.

The day came when I was to sit down and make my first amends. I prayed and talked with my sponsor. I was nervous, scared and unsure of what the outcome was going to be. I had to do it. I had to show, to God and myself, that I would be willing to set things right.

It was the first time that I *acknowledged* to someone, other than just my sponsor and God, exactly who I had been, and that I was willing to do different.

I assure you, as it was happening; it was not the most pleasant experience. But just moments later, I could look this person in the eye with assurance that with God's help, I was going to be different.

Almost immediately I felt a freedom from the "old me." Wow! I am sure some, probably many, know exactly what I am talking about.

So, that was the beginning of my journey of making amends. Some folks I had to send letters to. Some I have to send my amends to in heaven because that's where they reside now. Some people, I will never speak to because my job is not to harm them.

The point is, I became willing and need to remain willing to right the wrongs I have done. I must continue to acknowledge when I am wrong and continue to set things straight!

When they come trying to find us, we want each of them to get the same loving help we all had. The Conference—and the whole general service system—has that responsibility: to keep AA alive and well for those yet to come.
